New Vehicle Limited Warranty

Basic	1 year / unlimited mileage
Powertrain	2 years / unlimited mileage
Rust	5 years / unlimited mileage

Basic Warranty: The basic warranty covers everything except exterior and interior reproduction trim (moldings, badges, door handles, mirrors) and items that are subject to wear and tear or replacement in the ordinary course of vehicle ownership, such as oil and air filters, wiper blades and brake pads, subject to the exceptions and limits set forth below. Tires and batteries are excluded but may have their own warranty provided by the manufacturers of those items.

Powertrain Warranty: The powertrain warranty continues after the basic warranty has expired. This part of the warranty covers the engine (block, heads, fuel pump, powertrain control module, flywheel, manifolds, oil pan, oil pump, seals and gaskets, thermostat, timing chain, valve covers, water pump) and transmission (clutch cover, seals and gaskets, torque converter, transmission case, transmission mounts), subject to the exceptions and limits set forth below. Like the basic warranty, consumable parts such as hoses and belts are not covered. However, most of the internal parts of the engine, such as the pistons and bearings, which are also subject to wear and tear, are covered by the powertrain warranty. The powertrain is warranted by the manufacturer of the powertrain component, not by Revology Cars.

Rust or Corrosion Warranty: This warranty covers the vehicle's sheet metal and protects you from rust and corrosion severe enough to cause a hole, subject to the exceptions and limits set forth below. Body sheet metal panels are covered for an extended Corrosion Coverage Period, which lasts for five years, also with no mileage limit. The extended warranty coverage only applies if a body sheet metal panel becomes perforated due to corrosion during normal use due to a manufacturing defect in factory-supplied materials or factory workmanship. This coverage is void if there is no factory-related defect involved, e.g. the rust is caused by airborne material (e.g. environmental fallout), or if the vehicle is operated in extreme conditions, such as winter driving with continuous exposure to road salt, or when water drainage channels in the body are blocked due to road debris and/or lack of maintenance.

Exceptions: If non-standard components are specified, the warranty coverage for those components may vary from the standard Revology warranty. Modifications to the vehicle made by the customer after the vehicle is delivered may void the warranty for affected components. Warranty coverage is not available for vehicles exported outside the U.S. and Canada.

The New Vehicle Limited Warranty does not cover surface rust, deterioration, and damage of paint, trim, upholstery, and other appearance items that result from use and/or exposure to the elements. You, as the owner, are responsible for these items. Some examples are dings, dents, cuts, burns, punctures or tears, road salt, tree sap, bird and bee droppings, windstorm, lightning, hail, earthquake, freezing, water or flood, stone chips, and scratches.

Limits: The following limits apply to warranty claims:

1. All labor and parts expenses for approved warranty repairs for the basic warranty will be covered by Revology Cars, up to \$2,500 per incident, or \$5,000 per vehicle
2. All labor and parts expenses for approved warranty repairs for the powertrain warranty will be covered by the manufacturer of the powertrain component, at the discretion of the manufacturer
3. All labor and parts expenses for approved warranty repairs for the rust warranty will be covered by Revology Cars, up to \$10,000 per incident, or \$25,000 per vehicle

Procedure for Obtaining Warranty Repairs:

1. Contact Revology Cars warranty support at 800-974-4463 for pre-authorization. All warranty work must be pre-authorized by Revology Cars. Warranty claims may not be covered if not pre-authorized.
2. Based on the concern, Revology will determine whether the car should be brought to a local repair facility for repairs or if a technician should be dispatched to the client's location. If it is determined that the car should be repaired locally, Revology will coordinate with the nearest suitable repair facility to perform mechanical repairs. It will be the client's responsibility to transport the vehicle to the repair facility.
